












### DEAR DELEGATES AND INDUSTRIAL REPRESENTATIVES,





# **CANCELLATION POLICY**

#### **Terms & Conditions:**

This application, properly executed by Applicant (Exhibitor) shall, upon written acceptance and notification of booths assigned by ANIMMA Organizing Committee, constitute a valid and binding contract.

### 1. Assignment of Space

Assignment of space to exhibitors and those making application will be made in the order of email date. ANIMMA will continue to receive applications and assign exhibit space, as it remains available, until shortly before the exhibition opening date. In all cases, total booth payment must be received prior to exhibition opening. ANIMMA assignment of booths is final and shall constitute an acceptance of the Exhibitor's offer to occupy space. After assignment, space location may not be changed, transferred or cancelled by the Exhibitor except upon written request and with the subsequent written approval by ANIMMA. ANIMMA Organizing Committee reserves the right to reassign Exhibitor space or to modify floor plan for overall benefit of the exhibition.

### 2. Subletting Space

No exhibitor will assign, sublet, or apportion the whole or any part of the space allotted to him, nor exhibit therein, nor permit any other person or party to exhibit therein, any other goods, apparatus, etc. not manufactured or distributed by the Exhibitor in the regular course of his business except upon prior written consent of the ANIMMA Organizing Committee.

### 3. Payment Requirements and Cancellation Charges

Applications require a 50% deposit before final booth assignment is confirmed in writing. All applicants who contract after 1 January 2025 must be paid in full by 1 March 2025. All applications received after 1 March 2025 must be accompanied by full payment. All cancellations must be made in writing and will be based on the following schedule of refunds: Space reductions are considered cancellations and may be subject to cancellation fees. On or before 1 March 2025, 50% of total booth cost, less a €100 service fee, will be refunded. After 1 June 2025, no refund will be permitted. No-show exhibitors will receive no refund. It is understood that ANIMMA reserves the right, at its option, to reassign a cancelled booth regardless of the cancellation rate assessed. In the event that the premise in which the ANIMMA Organizing Committee Exhibition is conducted shall become, in the sole discretion of ANIMMA Organizing Committee, unfit for occupancy, or substantially interfered with by reason of any cause or causes not reasonably within the control ANIMMA Organizing Committee, this agreement may be terminated by ANIMMA Organizing Committee. For this purpose, the term "cause or causes" shall include, but not by way of limitation, fire, flood, epidemic, earthquake, explosion or accident, blockage, embargo, inclement weather, governmental restraints, restraints or orders of civil defense, or military authorities, act of public enemy, riot or civil disturbance, strike, lockout, boycott or other labor disturbance, inability to secure sufficient labor, technical, or other inability to obtain, or condemnation, requisition or commandeering of necessary supplies or equipment, local, state or federal law, ordinance, rule, order, decree or regulation, whether legislative, executive, or judicial, and whether constitutional, or act of God. Should ANIMMA Organizing Committee terminate this agreement pursuant to the provision of this paragraph the Exhibitor waives any and all claims for damages and agrees that ANIMMA Organizing Committee may, after computing the total amount of ANIMMA Organizing Committee cost and expenses in connection with its preparation for and conducting of the ANIMMA Organizing Committee Exhibition, (including a reasonable reserve for claims and other contingencies) refund to each exhibitor the amount paid for the space, less a proportionate share of all the expenses incurred by ANIMMA Organizing Committee.

### 4. Set-up and dismantling of the exhibition stand

A representative shall man the exhibit space during the entire time the Exposition is officially open. The exhibition space must be kept clean and tidy throughout the duration of the Exhibition. Once your reservation is confirmed, you will be given a schedule for the set-up and dismantling of your booth and materials to be exhibited. Failure to comply with this rule, including early dismantling, will result in a fine of 500 (Euro) and may jeopardize the exhibitor's space allocation or his right to exhibit at future conferences sponsored by the ANIMMA Organizing Committee.

### 5. Loss or Damage
